What happens when I limit sharing for an account I hold jointly with someone else?	Your choices will apply to everyone on your account

Definitions

Affiliates	Companies related by common ownership or control. They can be financial and nonfinancial companies KeyStone Financial, LLC does not have any affiliated companies
Nonaffiliated	Companies not related by common ownership or control. They can be financial and nonfinancial companies. These include companies who perform services or functions on our behalf such as custodians and trustees, data services providers, mail service providers, check printers and Fortegra insurance company
Joint Marketing	A formal agreement between nonaffiliated financial companies that together market financial products or services to you KeyStone Financial, LLC does not share your non-public personal information with any nonaffiliated financial companies
